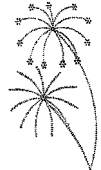

2. If you are ordering Display Fireworks, quickmatch, etc., you must provide/have on file a signed in black ink copy of your current ATF License or Permit and letter of listing the Responsible Persons or Employees authorized to possess explosive materials. **NO EXCEPTIONS!**
3. If you are ordering Consumer Fireworks that explode or fly up into the air for use in Minnesota, you must provide your MN Certificated Fireworks Operator # and a copy of the local fireworks permit. **NO EXCEPTIONS!**
4. If you are ordering for resale in Minnesota and do not want to pay the 6.5% MN Sales Tax, you must provide/have on file your MN Sales Tax ID # and a current completed and signed MN sales tax resale form. **NO EXCEPTIONS!**
5. **DO NOT SEND CASH!**
6. **NO CODs!**
7. Call in, mail or FAX credit card orders. Do NOT send via e-mail.
8. Freight will be calculated based on the best route, the type of products ordered and the desired delivery speed.
